Application for Water Service and Water Users' Agreement

The undersigned, being the owner or occupier of land within the above Rural Water District, hereby make application to said District for one water service, and upon approval of the Board of Directors or staff, agrees to the following conditions:

- 1. Purchase or cause to be purchased one (1) Benefit Unit for each water service at the unit price of \$4,500.00 (Due to fluctuations in the pricing from our vendors, the cost of a Benefit Unit is subject to change without notice) (Additional installation charges may also apply).
- 2. Pay a minimum monthly service charge of \$37.00 per month for each water service from the time water service becomes available and pay for the water used at the rate set out in the rate schedule adopted by the Board of Directors. Any changes made to the minimum monthly charge and rate schedule by the Board of Directors of the District shall become a part of this agreement as though fully set out herein.
- 3. The District will read all meters within the District and the water bill shall be due not later than the 15th day of the month following the month for which the bill is due as set forth in the water rate schedule. Bills not paid by the 15th of the month shall be subject to a \$3.00 late charge. Failure to pay a bill by the 15th day of the month following the month in which the bill is rendered shall result in a notice of discontinuance of the service.
- 4. The water service supplied by the District shall be for the sole use of owner or occupier of the land upon which the specific Benefit Unit is placed; as such the undersigned agrees that the owner or occupier of the land will not extend or permit the extension of pipes for the purpose of transferring water from one property to another, nor will they share, resell, or submeter water to any other tract or consumer. Each meter service shall supply water to only one residence located on land within the District.
- 5. If after water service is made available, the same is discontinued or disconnected for any purpose, pursuant to the By-Laws and the Rules and Regulations of the District, reconnection shall be upon the conditions set out in the By-Laws and Rules and Regulations of the District.
- 6. The undersigned agrees that they will make no physical connection between any private water system and the water system of the District. Representatives of the District may at any reasonable time come on the premises where the water is being used for the purpose of making inspection to enforce this provision. Violation of this provision shall be grounds for disconnection of service.
- 7. The laws of the State of Kansas, the By-Laws of the District, and the Rules and Regulations of the District, as presently existing, and as may be amended from time to time, are made part of this agreement as though fully set out herein.
